RELEASE OF LIABILITY

In CONSIDERATION of being permitted and given the opportunity to participate in any Heritage Coast Sailing and Rowing, Inc. (HCS&R) sailing/rowing program activities ("Sailing/Rowing Activities" or "Activity") for the period of **June 1, 2018 through June 30, 2018**, I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. **ACKNOWLEDGE**, agree and represent that I understand the nature of Sailing/Rowing Activities, both on the water and land based, and that I am qualified, in good health, and in proper physical condition to participate in such an Activity.
2. **FULLY UNDERSTAND** and that: (a) **Sailing/Rowing Activities involve risks and dangers** of serious bodily injury, including permanent disability, paralysis and death ("Risks" and "Dangers"); (b) these Risks and Dangers may be caused by my own actions or inactions, the actions and inactions of other participating in the Activity, the conditions in which the Activity takes place, or the negligence of the Releasees named below; (c) there may be other Risks and Dangers and social and economic losses either known to me or not readily foreseeable at this time; and **I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND DANGERS AND ALL RESPONSIBILITY OF LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the Activity.**
3. **AGREE AND WARRANT** that I will examine and inspect each Activity in which I take part as a member or participant of HCS&R and that, if I observe any condition to be unacceptably hazardous or dangerous, I will notify the proper authority in charge of the Activity and will refuse to take part in the activity until the condition has been corrected to my satisfaction.
4. **HEREBY RELEASE**, discharge, and covenant not to sue US Sailing, HCS&R, their administrators, directors, agents, officers, volunteers, employees, other participating event organizers, any sponsors, participants, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, (individually and collectively considered and referred to hereinafter as the "Releasees") from and with respect to all claims, actions, demands, losses, damages or other liability whatsoever and to any extent pertaining to or arising from any such Activity, including without limitation negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreements, I or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, defend, save and hold harmless each and all of the Releasees from and with respect to any litigation expenses, attorney fees, liability, damage, or cost which may occur as a result of such claim.
